IMPORTANT NOTE: Please fill out all the information fields above so that we can keep our membership database as up to date as possible. Our primary method of communication will be via email, so if you do not have an email address, we suggest you consider getting one.

DISCOUNTED GUEST PASSES: Members can purchase discounted guest passes in advance of the pool opening at the following rates and add them to your membership dues check submission.

10 passes for \$75.00 OR 20 passes for \$120.00.

When the pool opens for the season, additional discounted guest passes can be purchased at the following rates:

10 passes for \$90.00 OR 20 passes for \$145.00

NOTE: Discounted guest passes cannot be used for pavilion/facility rental events (birthday parties etc.) or as credits towards Clambake or any other GHA social event. All Guest Passes expire on pool closing date.

NEW MEMBERS: New memberships for 2025 (*those who have not been members in the last 10 years*) are 10% off of the normal membership rate for the 2025 season.. New Members are exempt from late fees.

WORK BOND/AREA OF EXPERTISE: For possible changes to work bond fulfillment opportunities, please let GHA know (line on the next page) if you have an area of expertise (masonry, plumbing, electrical, etc).

All GHA Members are required to work four (4) hours to fulfill their work bond requirement on designated days and working on designated tasks. Any combination of hours can be used for your work bond, such as 1 family member for 4 hours, or 2 for 2 hours, or 2 hours one day and 2 the next. New members are exempt from work bond. Households where all adults are 55 years or older and all children are 15 years of age and younger are exempt. Any household with at least one family member between the ages of 16 and 54 years living at home is obligated for work bond. Details to follow.
